 satisfied no threat exists. **FORMULATE YOUR TACTICAL PLANS.**
 (SITUATION E.G., suspicious persons, law enforcement action, being followed,...).

This is a draft Concept.

PURPOSE. THIS PROCEDURE IS FOR THE LIMITED PURPOSE OF ALLOWING PARTICIPANTS TO BE MADE AWARE OF FACTUAL SITUATIONS WITHOUT CAUSING PANIC. ACTIVE VOLUNTEER PARTICIPATION AND REPORTING IS NECESSARY FOR THIS TO WORK. IF NO ONE PARTICIPATES THEN THERE IS NO BENEFIT. You can either participate or not. That is up to you. This is an option for those interested.

If hear Code, then ALSO Monitor Sheriff / Cal Fire / other resources, etc... (but no social media gossip or low information sources ... , and no speculation). Make contact via phone with the participant who issued the code to determine additional facts.

DO NOT ENGAGE !

NONE OF US ARE THE POLICE. FURTHER, NONE OF US WANT TO JEOPARDIZE POLICE ACTIONS OR DISCLOSE INFORMATION WHICH MIGHT JEOPARDIZE THE SAFETY OF OTHER PERSONS OR LAW ENFORCEMENT.

USE THE CODES. THEN COMMUNICATE DETAILS WITH EACH OTHER ON TELEPHONE IF POSSIBLE.

REMEMBER, OTHER PEOPLE CAN HEAR EVERYTHING YOU SAY. YOU DO NOT WANT TO CAUSE PANIC OR HAVE STUPID PEOPLE START RANDOMLY TAKING ACTIONS WHICH RESULT IN DEATH OR INJURY. CALL 911 AS APPLICABLE.

RECOGNIZE THAT MOST PEOPLE HAVE NO PLAN FOR POTENTIALLY DANGEROUS SITUATIONS AND HAVE NO TRAINING. MOST LIVE IN A "BUBBLE" AND MAY VERY WELL BELIEVE THAT ..."HOME INVASIONS"... AND THE TERRORIST TYPE ATTACK ON ISREAL (OCTOBER, 2023) WILL NEVER HAPPEN TO THEM. MOREOVER, THEY HAVE NOT EVEN THOUGHT ABOUT THE POTENTIAL RAMIFICATIONS OF WHAT THEY MAY SAY ON THE RADIO, AND THEY HAVE NO PLAN. RATHER, THEY WILL JUST SAY IN "PLAIN ENGLISH" WHAT IS PERCEIVED AS HAPPENING. IN THIS REGARD ANYONE WHO ADVISES YOU THAT THE POLICE ONLY USE PLAIN ENGLISH DOESN'T KNOW WHAT THEY ARE TALKING ABOUT, OR ARE INTENTIONALLY LYING TO YOU.

Let's take a hypothetical example. Assume a lady advises on the radio "I am being followed"... Consider a potential risk. Assume some "well intentioned" person hears the lady in "distress" on the radio and decides he will help out. So he gets into his truck and starts to pursue the "suspect vehicle". An accident results and someone dies. It turns out that the "suspect vehicle" was an innocent person. The radio communication was well intentioned and the person who sought to help was "well intentioned" but no one thought about the potential ramifications of the communication over the radio. There was no "plan" on how to handle the communication or thought about the potential ramifications. Specifically, in this case, the response by someone unknown to the "lady" "in distress" who likewise had not thought about the consequences.

One last example. Assume a lady is at Reed's market and views a gun in the waste band holster of a man wearing a red jacket. A TX is made that there is a "man with a gun at Reed's market (red jacket)". A person driving by hears the TX and pulls into the parking lot. He sees the "suspect" and gets out of his vehicle and seeks to hold the "suspect" at gun point. He trips while his finger is on the trigger. A shot is fired and he kills the person who turns out to be an off duty police officer. Again, there was no "plan" on how to handle the communication and no thought about the potential ramifications of that communication by random people who are listening.

SO, YOU MUST PREPARE IN ADVANCE FOR YOUR FAMILIES SAFETY BY TRAINING AND PREPARATION. PART OF ANY PLANNING IS COMMUNICATION.

YOUR OBJECTIVE IS TO MERELY HAVE FACTUAL INFORMATION SO YOU CAN IMPLEMENT YOUR FAMILIES SAFETY PLAN, AND YOUR FAMILIES PLAN TO SECURE YOUR HOME.

OBTAIN TRAINING ON HOW TO SECURE YOUR HOME AND PROTECT YOUR FAMILY LAWFULLY.

USE EROC 9 FOR CODE TX. THEN, AFTER YOU DISCUSS MATTERS ON THE PHONE YOU MAY DETERMINE THAT THE MATTER IS A BONA FIDE SITUATION AND NOT A FALSE ALARM ETC...). THEN, YOU MAY DECIDE THAT IT IS PRUDENT TO ISSUE A GENERAL WARNING IN PLAIN ENGLISH ON EROC 9.

Thus, if a situation warrants (and using common sense), a general warning without specifics may be appropriate on EROC 9.

Example: "There is a public safety concern in the area of __(insert general area)__. Law enforcement is responding. IT IS RECOMMENDED THAT ALL PERSONS STAY AWAY FROM SUCH AREA FOR YOUR SAFETY. For information go to your local news."

THESE CODES ARE NOT SECRET. THEY ARE AVAILABLE.
