All operators should follow SER Procedures so that you can help out if needed. For SITREPS (FOR NON EMERGENCY TRAFFIC) ALL NETS (HAM AND NON HAM) TO USE Q CODE PROEDURES (FMT TANGO 9A OR FMT TANOG 9M). SUCH IS MORE EFFICIENT AND ALL OPERATORS NEED TO LEARN. DON'T RELY ON ONE PERSON TO CLEAN UP SLOPPY REPORTING. WHY? BECAUSE IF THAT PERSON IS NOT PRESENT, YOUR NEIGHBORHOOD IS IN TROUBLE. BUILD GOOD OPERATORS. BE COMPETENT. ONLY REPORT PROBLEMS. REPORTING NON RELEVANT INFORMATION SLOWS DOWN THE ENTIRE SYSTEM. USE THE SER FORMATS FOR REPORTING. IN EVENT OF LOW BATTERY (EMERG POWER), SUCH IS WASTING RESOURCES VITAL TO EMERGENCY COMMS. PLEASE FOLLOW THE PRO CEDURES.
